Hey Neel,

Yes, I do have a project in the works that would qualify, I don't mean to sound grandiose, but **my work is AGI.**

That the best in the field of AI only dream can happen in about 40 years, but I have a set of combinatorial technologies that if you saw the results, or say, **if China saw the results, they would assume we had created AGI, 40 years ahead of time.**

But.

1. **It's not a registered company**, it's just a project, that I was going to bring to Silicon Valley next year for funding. And let them sort out the company details.

2. By the looks of it, the grant fund has only £20,000 or so to give away from a £3m pool. **I need at least £1m (seed capital) and really I'm looking for £10 (Series A) with a VC or other who has a lot more once the system shows its metal.**

But I have enough now on a secure website to show anyone who knows the first thing about AGI. (Or at least ML and infra)
